

# Foreword – Lua Pellegrini

I thank the Advocate for spending time with the YAC at every meeting and recognise her mentorship, guidance and her ability to really take the time to listen to the voices of the twelve YAC members as well as children and young people more broadly.

As evident throughout this report, the work of the YAC could not have been achieved without the unwavering support of the Office of the Advocate for Children and Young People (ACYP). ACYP facilitate and support the work of the YAC not only during our meetings but throughout the entire year, including ensuring that the diverse voices of children and young people across NSW are heard.

Excitingly, this year ACYP launched the NSW Strategic Plan for Children and Young People at the Julia Reserve Youth Precinct in Camden, on Dharawal land. This Plan is one I am extremely proud of, and I thank ACYP and the NSW Government for their commitments to make tangible change in the lives of children and young people across our state.

Finally, I would like to acknowledge the members of the YAC for their work and dedication over our term. Although we began the term as strangers, we were quickly united by our drive to improve the lives and experiences of young people in NSW. Throughout our term, the YAC engaged with the New South Wales Education Standards Authority (NESA) on an ongoing basis regarding their curriculum review. We also provided feedback to ACYP and a range of external agencies including the Office of Sport, NSW Health and Sonder. The YAC were also able to complete Disability Awareness Training by Victory Beyond Vision and Young Carer Awareness Training by Carers NSW and participate, in what was a highlight for the YAC, the KYUP! Project. I thank my fellow members for ensuring that their voices and the voices of their communities were heard. I thank them for their willingness to share - openly and sincerely - their stories, skills and wisdom with the YAC, the Office, and external agencies.

Being Chair of the NSW Youth Advisory Council has been an absolute privilege and honour. It has shown me the importance of using my voice to ensure others are given an opportunity to use their voice, as through our own inimitable ideas and perspectives we can enact meaningful change in our own communities. I would encourage young people who seek change in their community to be part of that change, no matter how big or small, because our community is a better place when we listen to the voices of children and young people.

It is often said that children and young people are the future. Although I believe this to be true, it is not entirely accurate, as we are not only the future but also the here and the now, and we deserve the opportunity to have our voices heard today, tomorrow, and every day forward.

# **Role of the Council**

The NSW Youth Advisory Council (YAC) is established under the *Advocate for Children and Young People Act 2014*. The YAC provides young people with the opportunity to participate in the development and consultation of government policy that concerns them.

The YAC's functions under the Advocate for Children and Young People Act 2014 are:



Advising the Minister and the Advocate on government policies and programs concerning young people;



Consulting with young people, community groups and government agencies on issues and policies concerning young people;



Monitoring and evaluating legislation, government policies and programs concerning young people and recommending changes if required;



Conducting forums, approved by the Minister, on issues of interest to young people; and



Providing the Minister and the Advocate with information on issues and policies concerning young people.

# Administration of the Council

At the time of appointment, The Hon. Alistair Henskens, MP, Minister for Families, Communities and Disability Services, and The Hon. Bronwyn Taylor, MLC, Minister for Mental Health, Regional Youth and Women administered the *Advocate for Children and Young People Act 2014*.

In December 2021, The Hon. Natasha Maclaren-Jones, MP, Minister for Families, Communities and Disability Services, and The Hon. Ben Franklin, MLC, Minister for Tourism, Minister for Aboriginal Affairs, Minister for the Arts, and Minister for Regional Youth, took carriage of the Act.

Secretariat support for the Council was provided by the Office of the Advocate for Children and Young People (ACYP).

Council members have met on seven occasions' during their 2020-21 term:



# **Recruitment of the Council**

# The 2021-2022 YAC was recruited in early 2021 via an extensive recruitment and selection process.

YAC applications were open from 1 February 2021 to 14 March 2021, with more than 500 applications received. The Advocate for Children and Young People read all the applications with senior members of the Participation Team and determined a shortlist of 150 applicants.

Shortlisted applicants were invited to an online information session that was held on 13 April 2021, in which shortlisted applicants were addressed by then Minister for Families, Communities and Disability Services, Mr Gareth Ward, MP, the Advocate for Children and Young People, Ms Zoë Robinson and members of the 2020-21 Youth Advisory Council. During the session the applicants were provided with an insight into:

- The work of the Office of the Advocate for Children and Young people;
- The role and responsibilities of the NSW Youth Advisory Council;
- The work and highlights of the current NSW Youth Advisory Council; and
- A live Q&A session with the Advocate for Children and Young People and the chairperson of the 2020-21 NSW Youth Advisory Council.

Online group activity sessions were held across two days, on 14 and 15 April 2021. To aid the selection process, shortlisted applicants were allocated to the online sessions based on age. Participants were asked for their views on consultation questions provided by various NSW Government Departments (Department of Education, Transport NSW, Department Planning, Industry and Environment, Department of Premier and Cabinet, NSW Treasury, Department of Customer Service and NSW Ministry of Health).

Members of the ACYP office and Non-Government Organisations (NGO) representatives observed the applicants while they discussed their thoughts and ideas - as a group - on what they would recommend to the departments.

Following the online group activity sessions and further analysis by ACYP, the ACYP Participation Team determined 31 candidates to take part in a one day, face-to-face recruitment event on 6 May 2021 at the State Library of NSW in Sydney. Participants took part in a mock Council meeting, toured the NSW Parliament House and State Library of NSW, and engaged in a Q&A panel with NSW Government representatives.

Following the face-to-face recruitment event and further analysis by ACYP, The Advocate determined 12 candidates to recommend to the Minister for review and concurrence, which received Cabinet approval in July 2021.

# **Work of the Council**

## **Summary of the Meetings**

#### 22 August 2021 (online)

The first meeting of the 2021-22 YAC was conducted online over Microsoft Teams. The meeting began with an introduction and welcome by the Advocate. The YAC members were given the opportunity to introduce themselves to one another. The Advocate briefed the YAC members on their role and the members reviewed and amended their Code of Conduct. The YAC was consulted by the Advocate about the current COVID-19 outbreak in NSW and how the public health order was impacting them and their communities.

The YAC underwent advocacy and media training and were briefed on current ACYP initiatives, including the *NSW Strategic Plan for Children and Young People*.

The YAC undertook a consultation with NESA regarding their Curriculum Reform and were joined by three past YAC members for a Q&A panel discussion to hear of their experiences. The YAC were also introduced to NSW Youth Week and concluded the meeting by deciding on the theme for 2022: *"It's up to YOUth"*.

#### 10 October 2021 (online)

The meeting started by congratulating YAC member Alyssa for her work with the Minister for Health at the COVID press conference. In the 'hot topics' section of the meeting, members discussed the transition back to face-to-face learning at school and their concerns about returning.

The YAC explored options for transitioning back to face-to-face learning and discussed the potential of a hybrid model of learning post-COVID.

Members also discussed what they considered to be a healthy relationship and how to best navigate relationships.

The YAC met with NESA and discussed how stakeholders should be engaged and how young people interact through online platforms such as TikTok and other interactive feedback sharing avenues. Finally, members discussed the upcoming LGBTQIA+ project by ACYP and provided feedback on the project proposal.

#### 5 December 2021

The YAC had their first face-to-face meeting on Sunday, 5 December 2021. The Advocate for Children and Young People, Zoë, updated the YAC on the current work that the ACYP team is completing, including finalising the Out-of-Home Care Report and the initial stages of the LGBTQIA+ consultation process. Throughout the day, various YAC members participated in filming for the YAC promotional video for 2022-23, narrating for the Child Rights e-learning modules, and the Youth Week promotional videos.

Minister Henskens met with the YAC and discussed issues affecting young people in communities and discussed potential solutions for these concerns.

The YAC had a group discussion about 'hot topics' and requested a policy brief on Social Housing, which was a common concern among members.

A YAC member provided an engaging presentation on his charity, 'UR Voice'.

Members then reviewed the policy briefs requested in the previous meeting regarding the education reform (learning from home), young people and gambling, and discrimination in hiring and employment.

The YAC then consulted with NESA regarding the current curriculum reform, focusing on key learning areas for students in years 7-10. The YAC met with a variety of external agencies throughout the afternoon, which included the SIFE (School Is for Everyone) project run by university researchers. YAC members provided feedback on questions appropriate to ask young people and made suggestions on how to consult with young people effectively.

A representative from the NSW Office of Sport then met with the YAC to chat about the logistics of bringing a larger variety of recreational sport into regional areas. The YAC provided feedback on current strategies that the Office of Sport were using and suggested ways they could be improved to increase the accessibility of sports for regional communities.

The members also met with members of the Sonder App team, who presented and discussed their product. The YAC participated in a group discussion about the platform and highlighted both areas of success and potential improvements for the product.

Finally, the YAC participated in a fast-paced and engaging workshop with the KYUP Project. YAC members learned about boundaries and relationships and participated in an active session, learning self-defence techniques that could be used in a variety of situations.

#### 6 February 2022 (online)

The first meeting of 2022 was conducted online due to COVID-19 health advice. The meeting began with the Advocate's update on ongoing projects that the ACYP team were working on including the updated Strategic Plan, the LGBTQIA+ project and Out-of-Home Care (OOHC) Report.

The YAC discussed a wide range of 'hot topics' including Australia Day and the mounting calls for the day to be scrapped, COVID-19, the negative attitudes toward Grace Tame and social media wellbeing. Following discussion of the latter topic, YAC members requested access to a policy brief for the following meeting on the impacts on social media use on adolescent wellbeing.

YAC members were given the opportunity to present on a topic of their choice with two members choosing to speak. One member spoke about social media hygiene and the other member spoke about the work of their charity, Edify Australia.

The Office of Responsible Gambling was the first consult of the day, providing YAC members with insight into the proposed initiatives of the Office, including Gamble Aware and other educational programs. Members participated in a lively discussion about the impacts of COVID-19 on the heightened rates of gambling, impact of gambling on young people, and regulatory bodies as well as individual responsibilities. NESA continued their standing consultation sessions with the YAC, discussing critical and creative thinking during the meeting.

YAC members were joined by Anti-Discrimination NSW to raise awareness of the organisation and its roles and responsibilities, and were encouraged to share their lived experiences as young people and the discrimination young people face.

The last consultation for the meeting was held with the NSW Environment Protection Authority (EPA) in which YAC members advised the EPA on better ways to engage with young people and the EPA's new youth strategy.

YAC members were also asked to attend an out-of-session consultation with the NSW Department of Education regarding consent education in schools for Stage 4 PDHPE.

#### 27 March 2022

The meeting started with an Acknowledgement of Country and Advocate's update by detailing ACYP's involvement with the NSW Strategic Plan Launch, OOHC, Youth Week and LGBTQIA+ consultations.

The YAC raised 'hot topics' of increasing crime rates and the Environmental Minister's Duty of Care Appeal decision. Member presentations included Fairy Wren Movement (which aims to reduce eating disorder and mental health stigmas) and NSW SES (analysing logistics and the important role of volunteers).

The YAC requested policing briefs on the Impacts of social media usage and the Anti-Trolling bill. The YAC also requested a brief on how government budgets are allocated and who's accountable. Following on from 'hot topics' the YAC was updated on the knife crime project and the work that is taking place in youth justice centres targeting violence among young people.

Furthermore, the YAC had a consultation with NSW Department of Education (DOE) regarding student engagement in education. 'Adultsplaining' (when adults explain or act in a condescending way towards young people because they presume they have no knowledge about the subject matter) was flagged as the main concern!

The next session was with NESA and the NSW Curriculum Review, discussing skills development for post stage 6. This was followed by a disability awareness training session by Victory Beyond Vision.

Thereafter, the YAC consulted with the Mental Health Commission and DOE Diversity and Inclusion strategy. The meeting concluded with a final app review with Sonder.

#### 14 May 2022

At the May meeting, the YAC were updated on ACYPs work with Youth Justice NSW, LGBTQIA+ project and OOHC project. Topical issues included the upcoming election, increase in drugs and vaping, school COVID response plans and youth crime. Following this discussion, a member presented on School Strike 4 Climate.

YAC members then reviewed a policy brief on NSW State Budget allocations, noting the lack of youth involvement in these decisions.

Members had the opportunity to speak with The Hon. Ben Franklin MLC, Minister for Tourism, Minister for Aboriginal Affairs, Minister for the Arts, and Minister for Regional Youth about his role, goals and issues of concern.

Members were then consulted by NESA regarding support for young people's digital literacy skills in the curriculum. They also provided feedback on the development of the NSW Health Vaping Campaign and a new youth-friendly CommBank product design.



#### 26 June 2022

At the final YAC meeting, members began the meeting by reflecting with the Advocate on their highlights and learnings from their term and provided feedback to ACYP for the incoming YAC.

YAC members had the opportunity to speak with the Hon. Natasha Maclaren-Jones, Minister for Families and Communities and Minister for Disability Services. Members introduced themselves and raised several issues. YAC members then took part in a consultation with the ACYP team to discuss and provide feedback for the Annual Report.

This was followed by another consultation with NESA, this time on the topic of writing skills and student needs. The next guest to meet with the YAC was from Young Carers NSW, who provided information and insights, as well as raised awareness about Young Carers to the YAC. Members were given the opportunity to explore what opportunities were available to them following the end of their term as appointed members, which was done with the Advocate. Members were able to share what their next steps were.

YAC Members had their final consultation for their term. Members were provided with an opportunity to give ideas and feedback relating to Youth Week dates for 2023, 2024 and 2025.

Before finishing up their meeting, members were invited to share their feedback and reflections from their time on the YAC.

Members also completed postcards that will be passed on to the incoming YAC.

# **Advice Given to ACYP**



**Youth Week 2022** 22 August 2021

YAC members brainstormed and selected the theme *It's up to YOU'th* for Youth Week 2022.



#### NSW Children's Week 10 October 2021

YAC members provided ideas and suggestions for Children's Week 2022 activities.



#### LGBTQIA+ Consultation Project

10 October 2021

YAC members were one of the groups consulted by ACYP to inform the LGTBQIA+ consultation project. YAC members discussed their ideas and improvements for the project.



**Departmental** Questions

#### Youth Week 2022 - ACYP Departmental Questions

27 March 2022

The purpose of this session was for the YAC members to revise questions that had been drafted for different NSW Government departments to ensure they were youth friendly. The Departmental questions were to be used during consultation for Youth Week 2022 and YAC 2023 recruitment events.



#### **YAC Annual Report 2020-21** 14 May 2022

In this session, YAC members began to write the YAC Annual Report with assistance from ACYP to design, finalise and publish the document in 2022.



**NSW Youth Week 2023-25** 26 June 2022

In preparation for NSW Youth Week in 2023, 2024 and 2025, YAC members provided feedback on the dates and best timing for NSW Youth Week to maximise engagement with young people. YAC Members were also involved in an out-of session consult for NSW Youth Week Awards 2022.

# **Advice Given to External Agencies and Stakeholders**

Minister for Families, Communities and Disability Services

22 August 2021

The YAC met with the former Minister for Families, Communities and Disability Services online, who welcomed them to the Council.

YAC members introduced themselves and shared their areas of interest with the Minister.

#### **Human Rights Commission**

22 August 2021

YAC members participated in an out-of-session consultation with the Human Rights Commission. YAC members provided feedback and advice regarding the *It Stops with Me* campaign.

#### Sonder

22 August 2021 and 10 October 2021

YAC members provided feedback about their experience using the Sonder app.

#### Department of Customer Service

10 October 2021

YAC members provided feedback on what they felt was missing from the NSW Government website, and topics of inclusion in the young people space on nsw.gov.au.



# NSW Department of Education

YAC members met with staff from the NSW Department of Education to discuss consent education in schools.

YAC members provided feedback on their experiences of learning and teaching resources related to the consent curriculum.

### Minister for Families, Communities and Disability Services

5 December 2021

The YAC met with the former Minister for Families, Communities and Disability Services face-to-face, who again welcomed them to the Council. YAC members shared their areas of interest and spoke about issues that are important to them with the Minister.

#### Centre for Children and Young, Southern Cross University - SIFE Project

5 December 2021

YAC Members were consulted for the research project School is for Everyone: "Improving participation and wellbeing for every student." The YAC members provided feedback on how and when young people feel connected and as though they belong at school.

#### Office of Sport

5 December 2021

The YAC discussed and provided feedback on youth engagement within the Office of Sport and broader sport sector in their communities.

# Office of Responsible Gambling

6 February 2022

YAC consulted with the Office of Responsible Gambling to provide feedback on the projects they are developing for education and awareness purposes for young people.

#### Anti-Discrimination NSW 6 February 2022

The YAC met with staff from Anti-Discrimination NSW, who encouraged YAC members to talk about their lived experience and knowledge about the community to understand the common discrimination issues that exist within broader youth communities.

### NSW Education Standards Authority (NESA) Curriculum Reform

22 August 2021

The YAC provided feedback to NSW Education Standards Authority on the Curriculum Reform. The YAC provided general feedback on their experiences of the curriculum and NESA's website.

#### 10 October 2021

YAC members discussed Stakeholder engagement with the team from NESA.

#### 5 December 2021

YAC members discussed and provided feedback to inform the development of the reformed 7-10 syllabuses for Creative Arts, Geography, History, PDHPE, and Science and Technologies.

#### 6 February 2022

YAC members provided feedback on their experiences of learning about critical and creative thinking.

#### 27 March 2022

YAC Members provided input on the skills in applying knowledge needed in Stage 6 and for post-school pathways. This input will support NESA in the development of the new 7-12 syllabuses that 'prepare young people to be confident and creative individuals who are active and informed members of the community.'

#### 14 May 2022

YAC Members provided input on how to increase young people's digital literacy skills through curriculum. This input will support NESA in the development of teaching support materials linked to the new 7-12 syllabuses.

#### 26 June 2022

The purpose of the meeting was to gather input from the YAC relating to the development of writing skills in secondary school, including the writing demands of Stage 6 and post-school pathways i.e., university and work. YAC Members were asked a series of question for feedback.

### NSW Environmental Protection Authority (EPA)

6 February 2022

YAC members consulted with the EPA to develop initiatives to engage with and listen to youth. Feedback given will help inform the EPA's new Youth Strategy.

#### NSW Department of Education -Participation and Voice in Education

27 March 2022

The YAC provided input on student engagement experiences and anecdotes relating to their current or previous experience engaging with their educational settings, and what changes they'd like, or think are needed, for it to be a better experience. Feedback informed how the DoE shapes their framework.

#### Sonder

27 March 2022

The YAC were introduced to the Sonder app by Bryce Morton and how it can provide education, early intervention, and support for NSW young people. The YAC believed that the app was a good addition to the everyday world and can't wait to see it develop further.

### Mental Health Commission

#### 7 March 2022

YAC members were able to provide input and real experiences to the Mental Health Commission of New South Wales to provide feedback for them to consider when updating the suicide prevention strategic framework that was developed in 2018.

Alyssa spoke of the impact COVID-19 lockdown was having on young people and encouraged them to take advantage of the easement of restrictions to visit friends in a safe manner.

A YAC member was a guest speaker for the first Voices of Change event. Held in Sydney's CBD over breakfast, this event was an opportunity for key members of NSW Government, non-government organisations and the business community to listen to and ask questions about young people's experiences of and solutions to social issues impacting children and young people in NSW in 2022.



#### **KYUP Workshop**

5 December 2021

YAC Members participated in a KYUP Workshop that focused on leadership development. YAC members learnt about boundaries and relationships, as well as participated in an active session, learning self-defence techniques that could be used in a variety of situations.


